2426. THE FOLLOWING ITEMS WERE DISCUSSED AND RESOLVED

2426.1 Memorial for Marion Brighton – it was agreed to look at planting a tree at the back of the Pavilion the clerk is to investigate to see if this is appropriate. A request has been received and agreed from the family to site a bench within the village. An enquiry has been lodged with LCC requesting information on renaming Brighton Way to Marion Brighton Way.

2426.2 Retention of the Services of the current Internal Auditor – it was agreed to retain the auditor's

services for the foreseeable future.

2426.3 Diversion of traffic during closure of Heighington Road – it was agreed for the clerk to contact LCC Highways and ask if they would consider temporary traffic lights at junction of Church Hill/Lincoln Road/Main Road for the duration of the closure of Heighington Road.

2426.4 St Barnabas request to hold 'It's a Knock Out' and other events over the weekend of $5^{th} - 7^{th}$ July. It was agreed that the use of facilities for the Sunday would be without charge, however, whilst Council fully support the charity, they have agreed that they are unable to allow free use for the full weekend but will give a 50% discount of the full hire charge for the Friday and Saturday.

2426.5 LCC Grass Cutting Agreement – it was agreed not to take on the grass cutting from LCC.

2426.6 Lack of response to Parish Council vacancies – it was agreed that a general item be sent to Sheepwash Times, giving more information as to what is involved and the same article to go on social media

2426.7 Proposal regarding hire and charges of the Community Centre – this proposal was discussed in some detail, but was rejected by Council.

2426.8 Use of and payment for hire of the Community Centre – Council agreed that they definitely want to keep the Pantomime for the community to enjoy and as they feel that this is a special case they agreed a 40% reduction, of the Village Organisations rates from April 2019 to March 2020, for the hirer, which will be reviewed in November 2019.
