2432. **NOTES OF THE PREVIOUS MEETING** held on the 15th November 2018, were agreed and signed as the minutes.

2433. MATTERS OUTSTANDING/ARISING

- 2433.1 All tree work for this year has been completed.
- 2433.2 GalifordTry/LCC have accepted invite to Annual Parish meeting they would like to do a 30-minute presentation.
- 2433.3 Internal Auditor has agreed to continue providing services for the Council.
- 2433.4 Defibrillator at the Precinct Lincoln Co-op are not funding these at the moment. There is no budget, but will note request for the future.
- 2433.5 Memorial for Marion Brighton it was agreed to plant a flowering Cherry tree in Chapel Park, rather than one on the playing field. If a memorial bench is requested by the family this can be sited on the playing field near to the pavilion
- 2433.6 LCC request to look at temporary traffic lights at bottom of Church Hill during the Heighington Road closure this has been declined, all H&S been undertaken
- 2433.7 Keeble Drive alleviation Meeting held with LCC/ IDB regarding water flow into dyke running by the side of the dog walk. It was felt the level of silt coming into the dyke would not cause the need for any extra cleaning of the dyke.

2434. DISTRICT AND COUNTY COUNCILLOR REPORTS

NKDC reported: – cautiously optimistic regarding the budget for 2019/20; traffic lights at junction of Canwick Hill and Washingborough Road are being monitored; Lincolnshire Resilience forum have started Text Alerts for emergencies; refuse days will change for all residents over the Christmas/Ner Year period, side waste will be taken in the first collections after this period; NK Strategy is being updated.

LCC – new website www.theworldofwork.co.uk, with information for those leaving education; Lincolnshire roads can expect a portion of the £420m promised for road repairs; the Visit Lincolnshire website has been re-instated; Coastal Country Park, North Sea Observatory and Donna Nook are being improved for the tourist season; Children's Services have been inspected and the full report will be out shortly; Lincolnshire businesses have visited Hunan Province (China) to promote their products;
