## DISTRICT AND COUNTY COUNCILLOR REPORTS

NKDC: Church Hill speed limit is being modified; Electoral Review of NK wards by Boundary Commission; Central Lincs Local Plan, under 5 year review; Housing participated in the Housemark peer review of services against other authorities and have done extremely well; Washingborough Road closed from 17<sup>th</sup> February for four months, for LEB work and at a meeting, last week key problem points were discussed regarding the diversionary route and passed onto LCC. LCC: - Ward walk to take place with a provisional date of March 9<sup>th</sup>; cycling/footway talks with officers; LEB, meeting with portfolio holder to discuss the problems of the Washingborough Road closure.

The bar bond to be increase to £240 for the financial year 2020/21; The Arquiva Monies is paid into the Grants Reserves on a permanent basis: The Clerk to seek quotes for the valuation of Council assets; Projects from the forward plan for 2020/21 are window dressings for the Community Centre and Civic Office and work to changing rooms in the Pavilion, where possible; Council to organise and pay for the five-year electric check on the Bowls and Tennis Pavilions, should any work be required this will be passed to the relevant clubs.;
An additional intruder alarm panel for the Civic Office is to be purchased;
The Clerk and Assistant Clerk to progress one scp to 26 and 10 respectively;
The Groundsman, Caretaker and Environmental Warden to move to NALC Salary Scale (scp 1-5) and start on scp 1, with annual progression to scp 5:
