30. MATTERS OUTSTANDING:

32. PLANTING THE CAR DYKE FIELD AS A WILD FLOWER MEADOW:

33. SCARECROW COMPETITION:

It will be recommended that a competition go ahead, with a working party looking in to the running of the competition and with the possibility of seeking sponsorship from local businesses.

34. SPORTING CLUBS' HIRE CHARGES:

It will be recommended that fees for 2021/22 be pro-rata and that any club, using facilities in its pursuance of their club's activities, at any time during any one week, will be charged one week's amount of the annual hire charges.

The fees for 2021/22 to be decided by Full Council.

A repricing structure for the hire of sporting facilities will be looked at, by this Committee and recommendations made to Council so as to be in place for 2022/23 financial year.

is within the precept figure and this is hoped to remain so by the end of the financial year.
