### **Energy Prices**

Details from Central Government on the one-off Council Tax energy rebate are awaited. A new webpage has been established on the NKDC website (n-kesteven.gov.uk) regarding rising energy prices. It gives advice on how to contact your provider if you are struggling with payments and how to keep your home as energy efficient as possible. Advice continues to be provided by the Council to those who struggle manage financially including eligibility for existing help and signposting to other support. Once details of the Government package are received and ready for distribution, residents will be informed.

#### Levelling Up

Lincolnshire was not selected as one of the 9 areas which will form the next wave of devolution deals. However, given the Government's intention that devolution deals will be in place by 2030, the leaders of Lincolnshire Councils look forward to shaping what devolution will mean for our county and what benefits it might bring. Although the White Paper has been issued, there is still much to learn and understand about the devolution of powers and what investment might be forthcoming. This all needs to be balanced against the aspirations that Councils currently have for their communities

# County Councillors' Report

### February 2022

### **Budget Debate**

On Friday, the county council will assemble for its February full council at which we will debate and vote on the annual budget proposals for 2022 to 2023. As you know, despite an increase in our government funding, the county council continues to face significant financial challenges, with a shortfall of around £22m over the coming three financial years.

For example, we estimate our adult care costs will increase by around £13.5m in 2022/23 to ensure we can continue to deliver critical support to those who need it most. Therefore, we are proposing a three per cent increase in our adult care precept to help meet this need. Additionally, it now seems unlikely that central government will reverse last year's £12m cut in highways' funding. All county councillors know from the amount of mail that we get from our residents, that decent roads are a priority, so we have little choice but to step in again and plug the gap. As a result, we are now proposing a two per cent increase in general council tax to help make up the shortfall.

We remain mindful that this is also a difficult time for many families, with rising inflation and energy prices and any increase in council tax to cover the shortfall will have a direct impact on household budgets. However, I know you appreciate how important it is that we protect the frontline services on which our communities rely.

#### Levelling Up White Paper

Earlier this month, the government published its Levelling Up white paper. So, what does this mean for Lincolnshire? It gives Lincolnshire an opportunity to revise the way our communities are governed, our relationship with central government and how we may be able to access further funding.

Under the terms of the white paper, Lincolnshire County Council has been in talks with the unitary authorities on the south bank of the Humber, namely North Lincolnshire and North East Lincolnshire, to see if there are governance and economic advantages to working more closely via devolution deal. The county council and the two unitaries have identified ten reasons for pursuing a devolution deal:

More effective delivery of infrastructure to benefit:

- 1. Strategic growth and jobs in key sectors
- 2. Green recovery and a low carbon Lincolnshire
- 3. Transport that connects people to jobs and places
- 4. Unlocking housing and sustainable growth
- 5. Managing our unique rural environment

Better development of skills and opportunities to encourage:

- 6. Skills culture that promotes aspiration across Lincolnshire
- 7. Growing skills needed for future jobs in key sectors
- 8. Creating pathways and apprenticeships into new jobs
- 9. Increasing employment opportunities and productivity
- 10. Accelerating innovation, research and technology

It is felt that through closer working with our public sector partners and neighbouring councils, district councils and by redesigning organisations and services, through being innovative and offering support to the private sector, will we have a sustainable governance model under which communities can flourish and sustain themselves.
